- Applications to vote by proxy at this election must reach the Electoral Registration Officer at Pathfinder House, St Mary's Street, Huntingdon, Cambs, PE29 3TN by 5 pm on Thursday, 21st April 2011.
- Applications to vote by proxy at this election applied for on grounds of physical incapacity, where that physical incapacity occurred after 5 pm on Thursday, 21st April 2011, must reach the Electoral Registration Officer at Pathfinder House, St Mary's Street, Huntingdon, Cambs, PE29 3TN by 5 pm on Thursday, 5th May 2011.
