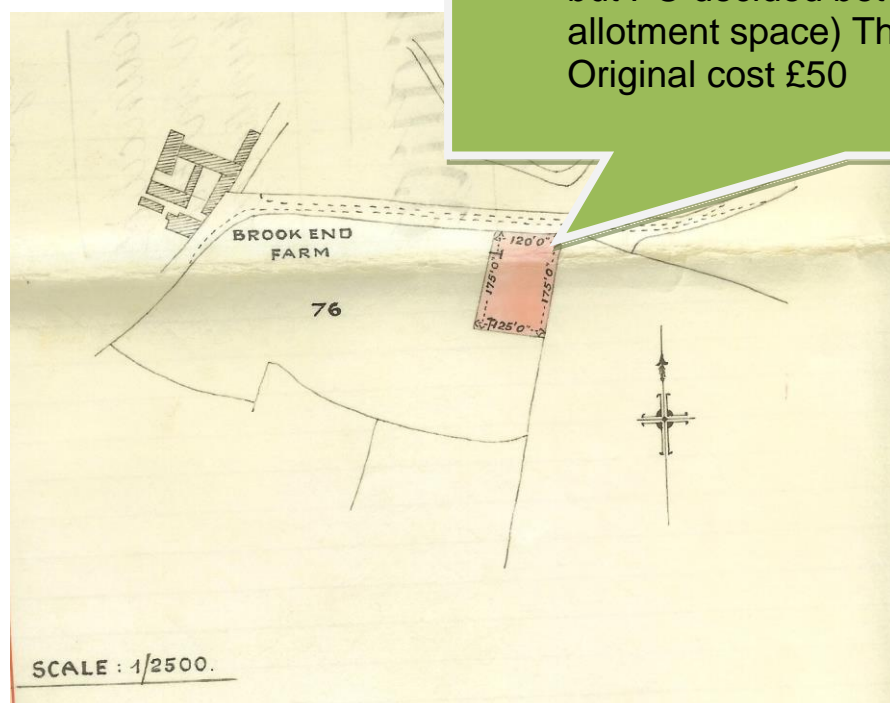


# HAIL WESTON PARISH COUNCIL ASSETS LAND OWNED

1. Allotments **Ford End, Hail Weston PE19 5JR**
2. Playing Field **Newtown, Hail Weston PE19 5JU**
3. Garden of Rest **High Street, Hail Weston PE19 5JW**
4. Burial Ground **High Street, Hail Weston PE19 5JS**

1. **The Allotments** were purchased on 2/3/1937 (originally purchased for the use of a cemetery but PC decided between 1939-1945 to provide allotment space) The Vendor was John Ingle. Original cost £50



2. **Playing field purchased 6/2/1959 from Frank Edward Catling. Cost £500.** A large (4.6 Acres) newly refurbished playing field which is fully enclosed with fencing and has hedging & mature trees planted around the perimeter. Open fields surround all sides except two. Kissing gate entry to the playing field containing a small childrens play area which is also fenced off, which includes swings, a bird nest swing, slide, monkey bars & climbing frame. Soft planting and an open sand pit break the expanse of playing field area. A footpath that is suitable for pushchairs and wheelchairs loops around the field leading to a BMX track, basket ball, cricket wall, zip wire, wooden fort and an adult exercise area. A free standing large wooden shelter and picnic tables completes the vast facilities.

### 3. Garden of Rest and Right of Way over a 3 foot strip of land marked on the plan.

Transferred by Deed of Gift 1/3/1977 by Donor Thomas Leslie Cobbold. The front part of land sited the former Baptist Chapel which closed in 1974. In 1975 the Home Office granted permission to demolish chapel and remove 5 graves. Property now known as 51 High Street.

4. **Burial Ground** purchased in 2010 as extension to Hail Weston cemetery, St Nicolas Parish Church.

The vendors sold for £15,000 with a covenant restricting land for burials only. The Vendors were the executors of Dr. R J H Harris. Following ecological assessments, planning permissions, environmental agency reports and re-positioning of electrical cables a plan identifying approximately 82 plots was adopted. Following significant clearance of site, as previously scrubland the cemetery was fully consecrated by the Bishop of Ely on 28.4.2013
