Material objections to be cited as dwelling layout & density of proposed building, overlooking neighbouring properties, Highways concerns, not in keeping with the village street scene and wildlife corridors.

HWPC have relooked at the mitigation as outlined in the Case Officer report submitted to address the wildlife concerns and are content as the wildlife trust and HDC planning officers have assessed and confirmed that with suitably worded conditions, and measures, the details highlighted in the ecology report including timings are suitable for the site. Also, HWPC are reassured that HDC have consulted with the' right of way team' CCC PROW to satisfy concern and look forward to hearing the outcome.

e. 'Eaton Bank' vision update: discussion ensued regard to 'apparent' late submission of this plan from developer or landowner (unknown to HWPC) relating to Bedford Borough Council 'Call for Sites'. The document submitted was of significant concern to HWPC who had seen the vision document via a resident facebook post. The original Call for Sites locations that had been submitted and had resulted in a HWPC objection to BBC and HDC at that time, related to a smaller area as identified as 'Flints field'. The Eaton Banks document had appeared to morph two geographical areas together resulting into a significantly larger proposed development. Clerk to engage with Duloe PC, BBC, land owner, ST Neots TC, HDC ward Cllr, HDC, CCC regard to clarification regard to timescales for assessment by BBC, (Spring 2022 unconfirmed) and information to help shape next steps for HWPC including engaging with residents.
