05/08/2020 - 20/01095/CLPD - Erection of single storey side extension following demolition of existing conservatory.16 Manor Way - Development response advised "this type of application is not for planning permission, it is asking if it is permitted development. Therefore, there are no consultations on this type of application. Any comments received will not be taken into consideration. If the certificate is refused to be issued as the works are not deemed permitted the applicant could submit a householder planning application for the works and it is then that consultations would take place and comments considered."

07/08/2020 - Government has tasked the District Council with the administration and payment of grants in relation to certain types of properties, dependent upon their status regarding the Business Rates database. VH may be eligible to receive a Retail, Hospitality and Leisure Grant.

10/08/2020 - briefing note regarding the open consultation on a radical overhaul of the planning system in England which was launched on 6th August by the Ministry of Housing, Communities and Local Government (MHCLG) which runs until 29th October 2020. Consider the consultation documents and submit responses on behalf of your Town or Parish Council directly to MHCLG.

<u>SLCC</u>: 23/07/2020 The Local Government Association (LGA) has drafted the Model Code to address one of the recommendations of the Committee on Standards in Public Life (CSPL)'s report of January 2019. The Model Code is designed to be adopted by both principal authorities and local councils. Code is based on 12 obligations for councillors. It is SLCC's view that the current draft is too focussed on principal authorities and fails to address the needs of local councils sufficiently – consultation closes 17/08/2020.
