Clerk 220719 - 9 **SM** - Neighbourhood watch joined and set up a group for Hail Weston Parish, which is pending approval. SM will provide an update post meeting on key outcomes and actions. PCSO contacted and yet to receive a reply. **RRS** - circulated Health & Safety report, outstanding items: replace the small gate: approved at the last meeting as part of the improvements for disabled access. Contractor has been contacted for the zip line, awaiting visit. Clarity required regarding RRS contractor to smooth out the BMX track required, central brace on Fort – continue to monitor, as per the ROSPA report. The 4th bar on the fort climb is loose and safety caps require fixing. Mound with the slide requires improvement. JH - Highways - Eastbound traffic on the B645, Vehicle numbers average 3792 per day. Improved on previous figures: @ 50mph 4.35% over limit - 95.65% abiding @ 53mph 1.96% over limit - 98.04% abiding Max speed 91 mph on camera approach 18/6 between 1am and 2am dropping to 50mph at camera. Traffic numbers taking the average from both directions are now equal to the Highways estimate of 7500 per day. (Highways estimate for 2025 is 7500 per day) For the camera situated at Green Lane Eastbound traffic: -@ 20 mph 30.71% over limit - 69.59% abiding @ 23 mph 12.97% over limit - 87.03% abiding

That is the best set yet at this site, maximum speed 56 mph on camera approach 23/6 12pm – 1pm dropping to 18mph at camera.

The second Solar panel is now fitted, and both realigned to enable camera exchanges to be much safer and easier. Timber fencing on the B645, weeds and overhang of vegetation by A1 flyover, continue to monitor.

CCC Ward Councillor Ian Gardener for Alconbury & Kimbolton: - New Shire Hall at Alconbury Weald was officially opened on Friday 8th July by the Chairman of the Council, Cllr Stephen Ferguson and pupils from Alconbury C of E Primary School. A cake in the shape of the CC Logo was made for the occasion by former Great British Bake Off Contestant Ian Cummings.

New Shire Hall forms part of a new Hub and Spoke model to deliver services closer to the communities they serve. This will save the public purse over 50m. Part of this sale was the sale of the Leasehold of old Shire Hall for conversion into offices and a hotel and can be purchased back by the County Council for a £1 in 40 years' time.

From July the County Council will be holding all its Council Meetings, including the Full Council at New Shire Hall in Alconbury Weald.

The main meeting rooms in New Shire Hall have been named after birds commonly seen in Cambridgeshire. The Multi-Function Room/Council Chamber will be known as the Red Kite Room.

Cambridgeshire CC is to spend 60m on expanding and enhancing provision for Children with Special Needs (SEND)

Two new schools will be built within the next two years at Alconbury Weald and Gamlingay for children with Special Needs The recently published 2021 Census shows that Cambridgeshire has seen one of the biggest population increases over the last ten years.

Overall the number of people living within the County rose by more than 57,000 in the last decade to 678,600. This is a 9.2% rise, which is higher than the East of England average. The national picture shows the east is the fastest growing region in the UK These figures confirm the County Councils contention over many years that the previous Office of National Statistics figures, on which it bases its grant allocations, were underestimating the size of the County's population.

Within these figures the number of people 65+ in the County rose by 26% against the National average of 18.6%

Huntingdon Library are making more space for young people. The new young Adult area was officially launched on Wednesday 6th July. The area will be bigger, more comfortable, offer more privacy and will feature more relevant book titles for young adults, using #BookTok. New services suggested by local young adults will also be launched.

Just a reminder that the **A1 between Buckden roundabout** and the Brampton Hut interchange and Wyboston will be closed

periodically in each direction, plus the full or partial closure of the Buckden roundabout, to allow for resurfacing, road stud replacement and white lining. This work is anticipated to last six weeks from 20th June until 01 August. This will consist of four weeks total weeknight working between 8pm and 6am and 24/7 across three weekends.

I have asked for National Highways to ensure that there is no rat running between the villages of Ellington, Grafham, Perry and Hail Weston and Gt Staughton to avoid these closures. As I understand it the A1 will be blocked at Wyboston and at Buckden to prevent HGV's travelling this route rather than the agreed diversion route via the A14/A1198 & A428 in either direction.

HDC Ward Councillor Stephen Cawley: COMMUNITY INFRASTRUCTURE LEVY: NEXT ROUND OF APPLICATIONS TO OPEN HDC is set to open the next round of Community InfrastructueLevy (CIL) applications on Monday 4th July 2022.

Applications are open to Huntingdonshire's Town and Parish Councils and infrastructure providers, with invites to apply to be sent out shortly. CIL is a planning charge placed on developers that allows local authorities to assist in the funding and delivery of infrastructure within the local area to support the needs arising from growth.

Previous applications for CIL funds have resulted in the support and improvement of many projects across the district including in the last round:

- Godmanchester Mill Weir
- Great Ouse Valley rights of way
- Ramsev St Marv's recreation around
- Hinchingbrooke Country Park
- Hinchingbrooke Hospital
- Sawtry 3G pitch.

Bringing the total District Council CIL investment for the previous round of applications to £2,061,320.00.

CAMBRIDGE AND PETERBOROUGH COMBINED AUTHORITY - LOCAL TRANSPORT AND CONNECTIVITY PLAN

- The CPCA is legally required to prepare a Local Transport Plan (LTP) for the area; the current plan was approved in January 2020.
- The first round of public engagement on an updated and expanded Local Transport and Connectivity Plan (LTCP)

ACTION

took place in November 2021. This initial engagement focused on establishing the main vision and goals of the LTCP and sought opinions on specific transport issues giving the opportunity to raise concerns over localised transport challenges and priorities.

- The CPCA has also engaged directly with Cambridgeshire County Council and all district councils in the area.
 Engagement has included workshops with members and an officer working group. Business engagement has also been undertaken.
- The overall strategy focuses on provision of an integrated transport network and is shaped by a series of guiding principles, which seek to support sustainable economic growth and decarbonise transport as part of the transition to net zero carbon emissions.
