JH – Highways - the first recordings from the camera recording Westbound traffic on the B645: Vehicle numbers average 2698 per day @ 50mph 8.59% over limit - 91.41% abiding, @ 53mph 3.12% over limit - 96.88% abiding. Not quite as good as Eastbound but close. Max speed 91 mph

Traffic numbers taking the average from both directions are now equal to the Highways estimate of 5600 per day, Highways estimate for 2025 is 7500 per day

For the camera situated at Newtown @ 20 mph 55.09% over limit - 44.91% abiding, @ 23 mph 33.03% over limit - 66.97% abiding, maximum speed 48 mph. Clerk to send RAW data to Speed Force Co-ordinator.
